Neither DELAWARE VALLEY GERMAN SHEPHERD DOG CLUB, nor anyone connected with the presentation of this event, assumes any responsibility for any loss, damage or injury sustained by spectators, exhibitors, handlers, or to any of their dogs or property and further assumes no responsibility for injury to their families or children.

The American Kennel Club Rules and Regulations will govern these Events. Exhibitors must make themselves familiar with the agreement of the American Kennel Club, referred to on the reverse side of the entry form that accompanies this Show Premium List.

An Event Service Fee of \$3.00 and a Recording Fee of \$.50 will be required for each dog entered at any Licensed or Member Club Show, Obedience Trial, or Tracking Test (4-6 Puppy \$2.00 Event Serve Fee). These fees are to be collected by the show-giving club and paid to The American Kennel Club. If a dog is entered in more than one class, the Recording Fee is to be collected on the first entry only (AKC Rule, Chapter 15, Section 2).

**ENTRIES RECEIVED WITHOUT FEES** will not be accepted.

**RETURNED CHECKS** do not constitute a valid entry fee. The Show Secretary will add a collection fee of \$40 to the amount of each returned check.

**TELEGRAPH, TELEPHONE and UNSIGNED ENTRIES CANNOT BE ACCEPTED.**

**ENTRIES NOT ON OFFICIAL AKC ENTRY FORMS AND PHOTOCOPIES OF ENTRY FORMS** without the Agreement and Rules on the reverse side of the Official AKC Entry Form are **NOT ACCEPTABLE.**

**NO ENTRY SHALL BE MADE AND NO ENTRY SHALL BE ACCEPTED WHICH SPECIFIES ANY CONDITIONS AS TO ITS ACCEPTANCE.**

**ERRORS ON ENTRY BLANKS.** Owners are responsible for errors in making out entry forms, whoever may make such errors, and no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date.

**NO REFUND FOR DUPLICATE ENTRIES.** We will make every effort to find all duplicate entries, but if a dog has been processed, no refund will be made. **ENTRY FEES** shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of the Show Committee. If because of riots, civil disturbances or other acts beyond the control of the club it is impossible to open or to complete the show, no refund of entry fee will be made.

**Refunds of entry fees less a \$4 fee for bitches in season on day of show in Obedience only by written request and with a written veterinarian statement.**

Refunds for cancellations due to judge change or cancellations made prior to entries closing will be mailed to said Exhibitor or Agent AFTER THE SHOW. An administrative fee of \$4.00 will be withheld from all refunds for entries cancelled prior to closing.

**ACKNOWLEDGEMENT OF ENTRIES will be made via email to the email address shown on entry form** as soon as practicable with the judging program. **SHOULD SUCH ACKNOWLEDGEMENT NOT BE RECEIVED BY THE EXHIBITOR** within a reasonable time, please notify the show secretary.

CONSULT JUDGING PROGRAM FOR TIME OF JUDGING.

DOGS MAY ARRIVE any time prior to their scheduled time of judging. **DOGS NOT REQUIRED** for further judging will be excused.

**JUDGES WILL NOT WAIT FOR ANY DOG HOLDING UP A CLASS.** Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged. The Show-giving club and the Superintendent have no obligation or responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

**ALL DOGS PRESENT** must be held on leash or confined to their crates except when being judged or when in the exercising ring.

**EXHIBITORS AND HANDLERS** will be held responsible for clean conditions in and around their crates and vehicles.

**THE SHOW COMMITTEE** will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, nor assume any liability in the event of an accident or misfortune to either dogs or exhibitors participating in this show.

**The Club may CANCEL the event due to extreme weather conditions.**

**No Parking on show grounds unless permission is granted by Show Chairperson.**

**AGREEMENT**

I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).

2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.

3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.

4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)

5. Mixed Breed dogs entering classes for Agility, Obedience, and Rally trials should mark Breed as "All-American Dog/Mixed Breed." Sire and Dam information shall remain blank for mixed breed entrants.

**From the Northeast Extension (Rt. 476)**, Exit 44 Quakertown. Turn West onto Route 663 (4.7 miles),

Turn right onto main Street (PA Rt. 29) (4.8 miles). Turn left onto Chestnut Street (PA Rt. 100) (3.7 miles). Turn right North Church Street (.4 miles). N. Church becomes Crow Hill Road (.3 miles). Follow to Bella Vista Lane and turn left.
